

# CAMP TECUMSEH COVID GUIDELINES

## REQUIREMENTS AND GUIDELINES FOR OUR STAFF

- All staff who may interact within 6 feet of guests will wear masks
- All staff will periodically take hand-washing breaks frequently during shift
- All staff will be asked to periodically check temperatures and other symptoms and report to supervisor
- Any staff who have a temperature or other symptoms will be required to stay home until they are symptom free for at least 72 hours
- All seasonal Outdoor Education Staff are fully vaccinated

## REQUIREMENTS AND GUIDELINES FOR OUR GUESTS

- Every guest is required to have a mask in their possession at all times
- Guests will be required to wear a mask indoors, except in individual cabins
- Guests are required to wear a mask indoors, or outdoors when within 6 feet or less of another guest or staff member
- We are asking all guests to check temperatures just prior to arriving at Camp and to stay home if temperature is above 100.4

## GENERAL FACILITIES

- Increasing locations of hand sanitizers to every program area, cabin, and dining hall
- Adding outdoor hand-washing stations (during temperate weather)
- Increasing cleaning and sanitizing using EPA-certified cleaning supplies
- Adding door stops in common spaces to decrease instances of multi-touch surfaces
- We are utilizing outdoor space for program space whenever possible

## CABINS

- We are opening up more cabin space wherever possible to encourage fewer numbers in each cabin and the spacing out of groups
- We are cleaning and sanitizing cabins between each group
- We are providing sanitizing wipes/spray for guests to use inside of the cabin during their stay
- We are giving guests access to turn on ventilation fans at their discretion (where available)

## DINING HALLS/MEALS

- We are requiring masks for guests as they enter dining hall and in line for food
- We are moving to either grab-and-go or modified buffet and family style food service
- We are hosting meals in shifts where needed to limit the number of guests inside at a time
- We are strategically selecting meal options to cut down on wait time and handling needed to serve

## PROGRAM AREAS

- We are adding signage to promote distancing while waiting in line
- We are increasing the cleaning/sanitizing of common items (bows, paddles, sleds, etc.)
- We are requiring mask use at indoor program areas
- We are strongly recommending mask use outdoors when a person is within 6 feet or less of

another person

- We are limiting the number of people allowed in/on program areas to allow for distancing
- Some program areas may be closed due to inability to sanitize/distance

## OUTDOOR EDUCATION PROGRAMMING

- Changing orientation areas to larger or outdoor spaces
- Keeping single groups together to limit cross-exposure
- Reducing the number of, and sanitizing, common-use items
- Replacing some team-building elements with others that are low/no-touch

*SPECIAL NOTE: At this time, we are running all programs with COVID guidelines in place while monitoring the situation and adhering to CDC guidelines, and local health departments.*
